1. Call to Order

Dave Pine, Chair of the Governing Board, called the meeting to order at 11:01 A.M. Chair Pine provided Zoom teleconference meeting instructions.

2. Roll Call

5. Chair's Report

Dave Pine, Chair of the Governing Board, gave a brief update on the Governing Board tour of the Montezuma Tidal and Seasonal Wetland Restoration Project and the Suisun Marsh Fish Screen Rehabilitation Project.

Chair Pine recognized the achievements of Executive Officer Sam Schuchat on his retirement. A resolution was read, board members discussed. Resolution in Honor of Sam

- H.R. 610, the bill to establish the federal San Francisco Bay Restoration Act, and climate resilience funding in state budget bills, including funding for San Francisco Bay Restoration Authority projects.
- The Governor's executive order regarding requirements for public meetings.

Quality, Biological Resources, Cultural Resources, Noise, Tribal Cultural Resources

and the Authority finds that there is substantial evidence that the mitigation measures

identified in the MND will avoid, reduce or mitigate any possible significant

environmental effect of the project to a less-than-significant level.

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed five hundred thousand dollars (\$500,000) to the SPHERE Institute to conduct site studies and community engagement, prepare detailed plans and detailed designs, prepare regulatory permit applications and environmental review documents, and prepare a long-term lease application for the Shoreline Park – Burlingame Project, which will transform a 9.4-acre vacant parcel of State-owned bayfront land into a public nature and recreation park and will include restoration of approximately 3-3.5 acres of tidal marsh and transition zone habitats along the shoreline in San Mateo County (Exhibit 1). The proposed education center at the park will be designed to include the best possible bird safety features. Prior to commencement of the work, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be retained in carrying out the project.
- 3. A plan for acknowledgement of Authority funding.

Findings:

Based on the accompanying staff recommendation and attached exhibits, the San Francisco Bay Restoration Authority hereby finds that:

- 1. The proposed authorization is consistent with The San Francisco Bay Restoration Authority Act, Gov. Code Sections 66700-66706.

Restoration and Adaptation Project ("the project"). The restoration and sea level rise

adaptation actions are expected to expand marsh habitat, increase flood protection, and

provide public access at the mouth of Colma Creek in South San Francisco (Exhibit 1).
