## 9. San Leandro (Lisjan) Creek Community Project

#### **Resolution:**

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to one hundred thousand dollars (\$100,000) to the Social Good Fund, fiscal sponsor of the David R. Brower, Ronald V. Dellums Institute for Sustainable Policy Studies and Action, to host community planning meetings, provide workforce education and training for creek stewardship, and install native vegetation at San Leandro Creek in Alameda County. Prior to commencement of the project, the grantee shall submit for the review and written approval of the Executive Officer of the Authority the following:

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be employed in carrying out the project.
- 3. A plan for acknowledgement of Authority funding.
- 4. Evidence that all permits and approvals required to implement the project have been obtained.
- 5. Evidence that the grantee has entered into agreements sufficient to enable the grantee to implement, operate, and maintain the project.

## **Findings:**

Based on the accompanying staff recommendation and attached exhibits, the San Francisco Bay Restoration Authority hereby finds that:

- **1.** The proposed authorization is consistent with The San Francisco Bay Restoration Authority Act, Gov. Code Sections 66700-66706.
- **2.** The proposed authorization is consistent with The San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure (Measure AA).

- 1. A detailed work program, schedule, and budget.
- 2. Names and qualifications of any contractors to be employed in carrying out the project.
- **3.** A plan for acknowledgement of Authority funding.
