Staff anticipates meetings running between 2 and 3 hours and proposes posting meetings with an anticipated end time determined by the number of items on each agenda.

The Brown Act allows for board members to join the meeting remotely from an alternate location as long as the alternate location is open to the public, ADA-accessible, and identified on the agenda. The agenda must be posted at each alternate location. The public will be able to join the meeting from the Metro Center, the alternate locations, or by teleconference.

Adopting the 2024 San Francisco Bay Restoration Authority Governing Board Meeting Schedule

Whereas, the San Francisco Bay Restoration Authority ("Authority") was established by the San Francisco Bay Restoration Authority Act, California Government Code Section 66700 et seq. as a regional entity to generate and allocate resources for the protection and enhancement of tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

Whereas, the Authority is subject to the Ralph M. Brown Act ("Brown Act"), Government Code Section 54950, et seq., which requires the Authority to establish a schedule for holding its regular meetings.

Now Therefore Be It Resolved, that the Governing Board of the San Francisco Bay Restoration Authority hereby adopts the 2024 San Francisco Bay Restoration Authority Governing Board Meeting Schedule set forth below. Meetings will be held at the Bay Area Metro Center in San Francisco, with one or more Board members potentially participating virtually from alternate publicly accessible locations that will be identified on the agenda and that will comply with the Brown Act.
