



**Resolution No. 115**

**Appointing a New Member to Represent Communities for a Better Environment on the  
Restoration Authority Advisory Committee**

**Whereas**, the San Francisco Bay Restoration Authority (“Authority”) was established by the San Francisco Bay Restoration Authority Act, California Government Code Section 66700 et seq. (“Act”) as a regional entity to generate and allocate resources for the protection and enhancement of tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

**Whereas**, the Act provides for a Bay Restoration Advisory Committee (“Advisory Committee”) to advise the Governing Board of the Authority; and

**Whereas**, in June of 2016, The San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure (“Measure AA”) passed with over a two-thirds majority in the nine-county San Francisco Bay Area; and

**Whereas**, Measure AA describes additional responsibilities of the Advisory Committee; and

**Whereas**, at its October 14, 2022 Governing Board meeting, the San Francisco Bay Restoration Authority adopted an amended *San Francisco Bay Restoration Authority Advisory Committee Procedural Document* (“Procedural Document”); and

**Whereas**, the Procedural Document states that an entity represented on the Advisory Committee may request in writing the designation of a new appointee to represent their entity, for example, if their current representative changes positions or leaves the entity or if the entity desires a different representative; and

**Whereas**, Communities for a Better Environment is an entity represented on the Advisory Committee and has requested the designation of a new appointee;

**Now Therefore Be It Resolved**, that the Governing Board of the San Francisco Bay Restoration Authority hereby appoints Devin Murphy to represent Communities for a Better Environment for a term beginning on October 20, 2023 and ending on June 30, 2027.
