Resolution No. 117

Appointing the Vice Chair of the Restoration Authority Advisory Committee

Whereas, the San Francisco Bay Restoration Authority (“Authority”) was established by the San Francisco Bay Restoration Authority Act, California Government Code Section 66700 et seq. (“Act”) as a regional entity to generate and allocate resources for the protection and enhancement of tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

Whereas, the Act provides for a Bay Restoration Advisory Committee (“Advisory Committee”) to advise the Governing Board of the Authority; and

Whereas, in June of 2016, The San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure (“Measure AA”) passed with over a two-thirds majority in the nine-county San Francisco Bay Area; and

Whereas, Measure AA describes additional responsibilities of the Advisory Committee; and

Whereas, the San Francisco Bay Restoration Authority has adopted the San Francisco Bay Restoration Authority Advisory Committee Procedural Document, adopted April 27, 2016, and last amended October 14, 2022 (“Procedural Document”); and

Whereas, the Procedural Document states that the Governing Board will appoint an Advisory Committee Chair who will be responsible for running meetings and compiling meeting notes to deliver to the Governing Board and serve as a liaison between the Advisory Committee and the Governing Board; and

Whereas, the Procedural Document states that the Advisory Committee will also have a Vice Chair, who will act as chair in the chair’s absence; and

Whereas, on May 5, 2023, the Governing Board appointed a Chair and Vice Chair to serve for two-year terms, but the Vice Chair position was vacated in June 2023; and

Whereas, on September 15, 2023, the Advisory Committee nominated Sara Azat, Fish Biologist, National Oceanic & Atmospheric Administration (NOAA) Fisheries, for Vice Chair.

Now Therefore Be It Resolved, that the Governing Board of the San Francisco Bay Restoration Authority hereby appoints Sara Azat, Fish Biologist, NOAA Fisheries, as Advisory Committee Vice Chair, for a term beginning on October 20, 2023 and ending on May 5, 2025.
