### 1. Call to Order

Dave Pine, Chair of the Governing Board, called the meeting to order at 11:02 A.M.

#### 2. Roll Call

Paul Johnson, Clerk of the Governing Board, reported that five (5) members were present: Sophie Hahn, Aaron Peskin, Lisa Gauthier, John Gioia, and Dave Pine.

### 5. Chair's Report

Chair Pine honored the memory of Senator Dianne Feinstein who was instrumental to the prosperity of the San Franciso Bay. He also mentioned that the West Bay Board Tour on October 6<sup>th</sup>, which toured several projects, had a successful turnout.

### **6.** Executive Report

Amy Hutzel, Executive Officer, presented a time-lapse video of the Terminal 4 Wharf Demolition Project in Richmond. She noted that this is the largest creosote pilling removal project in San Francisco Bay to date. Along with removal of pilings, the project will contain subtidal and intertidal restoration. The Ravenswood Breach Event is planned for December 13<sup>th</sup>. Escrow closed on August

30<sup>th</sup> for the Camp 4 Ranch Acquisition in Sonoma County, the Authority's first land acquisition grant. The acquisition will help implement the Sonoma Creek Bayland Strategy. October 10<sup>th</sup> was the deadline for responding to this year's request for proposals. Staff received 17 proposals totaling approximately \$73,000,000. The review process for reviewing applications has started and staff will work with the Advisory Committee on that effort. Staff presented to the San Mateo Council of Cities in July. The State Coastal Conservancy is submitting multiple applications for NOAA funding, which will, if successful, support projects also funded by the Authority. The Lower Walnut Creek Restoration Project by the Contra Costa County Flood Control District won the National American Public Works Association Project of the Year in the environmental category. Staff is working on a response to the Oversight Committee findings and recommendations.

Taylor Samuelson, Public Information Officer, presented an overview of the annual report summary for the fiscal year 22-23.

Sara Haugen, Project Manager, presented the interactive map of Authority projects.

Amy Hutzel presented the proposed Authority Governing Board meeting schedule for 2024. Resolution 114 *Adopting the San 2024 Francisco Bay Restoration Authority Governing Board Meeting Schedule* was moved and seconded.
