8. Lower Walnut Creek Restoration Project (Augmentation)

Resolution

The San Francisco Bay Restoration Authority hereby authorizes the disbursement of an amount not to exceed three million dollars (\$3,000,000) to the Contra Costa County Flood Control and Water Conservation District (District) to augment the grant of \$7,929,855 previously authorized by the Authority on December 6, 2019, for implementation of the North and South reaches of the Lower Walnut Creek Restoration Project, consisting of restoration and enhancement of brackish tidal wetlands and adjacent uplands along the southern shore of Suisun Bay, Walnut Creek and Pacheco Creek in Contra Costa County. All conditions of the Authority's prior authorization to grant funds for this project apply to this augmentation.

Findings:

Based on the accompanying staff recommendation and attached exhibits, the San Francisco Bay Restoration Authority hereby finds that:

- 1. The proposed authorization is consistent with The San Francisco Bay Restoration Authority Act, Gov. Code Sections 66700-66706.
- 2. The proposed authorization is consistent with The San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure (Measure AA).

12. Executive Reports

Luisa Valiela, U.S. Environmental Protection Agency, presented on U.S. EPA DRAFT San Francisco Bay Geographic Program Priority List.

Amy Hutzel, Executive Officer, highlighted that the Coastal Conservancy has submitted a \$75 million grant application to the National Oceanic and Atmospheric Administration, which successfully passed the initial phase. The U.S. Army Corps of Engineers, San Francisco District, is closely monitoring the Strategic Aquatic Placement Pilot Project. This process involves transferring dredge sediment from Redwood City Harbor across the Bay to the Eden Landing shoreline, aiming to assess the cost-effectiveness of nourishing marshes and mudflats. Additionally, the Corps of Engineers played a significant role, contributing 80% of the dredge sediment utilized for beneficial purposes in the Montezuma Wetland Restoration Project this year. On December 14th, 2023, a noteworthy event took place—the restoration of Salt Pond R4, spanning around 300 acres in the Ravenswood ponds. A news clip depicting the levee breach was aired, drawing attention to the event. The news clip was played for the Board.

Advisory Committee (AC) Chair Jessica Martini-Lamb presented an update on the Committee's activity since the October 20 Governing Board meeting. The AC last convened on November 3rd, where the agenda included the presentation of the BRITT Annual Report and the BCDC Sediment for Wetland Adaptation Project. During the meeting, the AC received an update from Authority Staff on proposed Equity Guidelines. Members were tasked with considering whether to recommend the adoption of these guidelines to the Governing Board. A robust discussion ensued among committee members regarding whether to allow additional time for Authority staff to address comments from the AC and bring the guidelines back at the next meeting or to expedite the process by recommending them to the Governing Board right away. The AC voted to direct Authority staff to respond to comments and revisit the equity guidelines at the next meeting in February. The February meeting will also feature an update on the development of tribal engagement recommendations.
