Resolution No. 128

In Recognition and Appreciation of Dave Pine
for Outstanding Service as Chair of the Authority Governing Board

Whereas, Dave Pine, in his role as Chair of the San Francisco Bay Restoration Authority (“Authority”), has been a dedicated champion of protecting and enhancing tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

Whereas, Dave Pine served on the San Mateo County Board of Supervisors from 2011 to 2024 representing District 1 which includes Burlingame, Hillsborough, Millbrae, and portions of San Bruno and South San Francisco; and the unincorporated communities of San Mateo Highlands, Baywood Park and Burlingame Hills, serving as Board President in 2014 and 2018; and

Whereas, Dave Pine served as a board member for the San Francisco Bay Conservation and Development Commission, the San Mateo County Flood and Sea Level Rise Resiliency District Board, and the San Francisquito Creek Joint Powers Authority, and worked extensively and tirelessly on issues of flood protection and sea level rise adaptation for the people of San Mateo County and the San Francisco Bay Area; and

Whereas, Dave Pine is the founding chair of the Peninsula Clean Energy Authority and served on the boards of the San Mateo County Transit District, the Peninsula Corridor Joint Powers Board (Caltrain), the Bay Area Regional Collaborative, and Joint Venture Silicon Valley; and

Whereas, Dave Pine was instrumental in the placement on the ballot in the nine-county Bay Area of Measure AA, an unprecedented regional measure to address impacts of sea level rise and restore the health of San Francisco Bay for people and wildlife; and

Whereas, Dave Pine led the work of the Authority to create a new grant program, set up an Advisory Committee and Oversight Committee, develop plans for equity and tribal engagement, support regional monitoring, and improve coordination on permitting for restoration projects; and

Whereas, under Dave Pine’s leadership, the Authority granted \$162,927,162 to 41 projects to restore tidal wetlands, improve coastal flood protection, and provide public access to the San Francisco Bay, greatly contributing towards the science-based goals for habitat restoration in the Bay; and

Whereas, Dave Pine has provided ongoing support for the staff of the Authority, and the staff have benefited and learned from his calm leadership and commitment to public service;

Now Therefore Be It Resolved, the Authority hereby recognizes and expresses gratitude to Dave Pine for his years of distinguished service to the people and environment of the San Francisco Bay Area.
