**Resolution No. 129**

In Recognition and Appreciation of Susan Gorin  
for Outstanding Service as a Member of the Authority Governing Board

**Whereas**, Susan Gorin, in her role as a member of the Governing Board of the San Francisco Bay Restoration Authority (“Authority”), has played a key part in protecting and enhancing tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

**Whereas**, Susan Gorin was first elected to the Sonoma County Board of Supervisors in 2012 and served as the Chair of the Board of Supervisors in 2015, representing the First District of Sonoma County, which is primarily eastern Santa Rosa, Sonoma Valley bordering San Pablo Bay, and areas east to the Napa County line; and

**Whereas**, Susan Gorin served on the Sonoma County Water Advisory Committee, Local Agency Formation Commission, Sonoma County Transportation Authority, Sonoma County Regional Climate Protection Authority, Sonoma Valley County Sanitation District, and the Sonoma County Waste Management Agency; and

**Whereas**, Susan Gorin represented Sonoma County regionally on the San Francisco Bay Conservation and Development Commission, North Bay Water Reuse Authority, and Association of Bay Area Governments; and

**Whereas**, Susan Gorin has served as an Authority Governing Board member since 2017 and has played a key role in the annual grant program, the work of the Advisory Committee and Oversight Committee, and the distribution of funding to projects throughout the Bay Area to restore shoreline habitats, improve coastal flood protection, and provide public access throughout the San Francisco Bay Area; and

**Whereas**, during Susan Gorin’s time on the Authority Governing Board, the Authority authorized funding for key North Bay projects, including the Sonoma Creek Baylands Strategy and multiple phases of the San Pablo Baylands Collaborative Protection and Restoration Project; and

**Whereas**, Susan Gorin has been an encouraging proponent for the Authority staff’s work, and the staff have benefited from her steadfast support and dedication to public service;

**Now Therefore Be It Resolved**, the Authority hereby recognizes and expresses gratitude to Susan Gorin for her years of distinguished service to the people and environment of the San Francisco Bay Area.
